The financial bids of only those firms shall be opened who qualify in pre-qualification bid. Intimation in respect of opening of financial bids shall be notified separately.

Cost of tender document (in shape of Demand Draft) and Earnest Money Deposit (In shape of CDR/FDR) in original, favouring **Managing Director, SICOP** super scribed as "Pre-Qualification Bid" should reach in the office of FA/CAO SICOP in person or through speed post/Regd post/Courier before due date & time of submission of bid.
