**Government Order No: 342-Ind (DIC) of 1995
Dated : 01.11.1995**

In supersession of all previous instructions, guidelines and orders, it is hereby ordered that :-

- A) All purchasing departments/organizations of the Government including Public Sector Undertakings shall henceforth place orders directly with SICOP for these articles which are manufactured in the SSI sector and form Annexure "A" to this order.

SICOP shall ensure that the articles indented for are supplied to the indenting departments at reasonable rates to be determined through tendering procedure by SICOP. SICOP shall also ensure standardization of the articles mentioned in the annexure "A" to this order, and that all indented articles, before they are supplied to the indenting departments are subjected to strict quality control measures.

The orders that SICOP may obtain from the indenting departments for any of the articles of manufacture mentioned in Annexure "A" to this order shall be distributed equitably amongst the registered SSI unit.

This shall, however, be subject to the condition that SICOP will ensure:-

1. that the prices offered are competitive;
2. that quality standards are complied with;
3. delivery of supplies is made in time.

In case SICOP fails to adhere to any of the aforementioned stipulations for reasons which cannot be justified by SICOP, the indenting department shall be left free to make arrangements for purchases so they deem fit and in the best public interest.

- B) In respect of items which are manufactured in the SSI sector but are not listed as reserved for the SSI sector as per Annexure-"A" to this order and for which the Government Departments invit open tenders, SSI units tendering directly will get upto 10% price preference whereas SICOP tendering on behalf of SSI units will get upto 12 ½ % price preference.

- C) The procedure envisaged in clause-4 of Gover. Order No.-10-Ind of 1995 dated 19.1.1995 shall remain operative in respect of all items except those mentioned in Annexure _"A" of this order.



In continuation of Government Order No: 342- Ind (DIC) of 1995 dated : 01.11.1995 read with Government Order No: 418-IND of 1997 dated 06.10.1997 sanction is hereby accorded to the inclusion/ deletion of the following items in the list of "Reserved Category" items indicated in the said Government Orders to be purchased from SSI units through SICOP.

This issues with the concurrence of the Finance Department vide No: ET/Estt/2007/2008 dated 19.8.2009 and subject to the following conditions in addition to the conditions stipulated in the Government Order No. 342- IND (DIC) of 1995 dated 01.11.1995:

1. The Industries & Commerce Department shall take periodical review of the implementation of the policy of marketing support for wider dispersal to SSI units in areas that are industrially and economically backward. Such dispersal shall not be at the cost of the quality of the product and competitiveness of rates so that both the indenting departments as well as the SSI units are evenly benefitted.
2. The policy of reservation is only to be extended to items manufactured within the State of J&K.
3. Preference to the Joinery Units of J&K Industries Ltd. shall be subject to the modalities decided by the Industries & Commerce Department and shall not be permitted at the cost of competitiveness of rates, prescribed quality standards under BIS and timely execution/ supply to indenting Departments. In case of the inability of JKI to adhere to these stipulations, orders will be placed with SSI units through SICOP as per the Standing Government Policy.

4. SICOP shall ensure adherence to quality standards in all respects as per the norms prescribed by BIS from time to time.


