ORDER

Subject: - Enquiry regarding P/F of Steel Garden Benchs to Principal Govt. Degree College, Kupwara.

Whereas, pursuant to the letter No: No: IND/SICOP/11/2012 dated 10.12.2015 received from Administrative Department, the management vide order No: 131-GM (Hqr) of 2015 dated 29.12.2015 appointed Mr. G.H.Lone, Divisional Manager as Inquiry Officer for conducting of enquiry in the matter of supply of under specification material to the Principal, Govt. Degree College, Kupwara through M/s. Javid Furniture Works, Iqbal Pora , Chadoora thus causing loss to the state exchequer.

Whereas, the delinquent officers namely Mr. Shabir Ahmad, Rafaie AE (retiree) and Mr. Shahid Sharief Dar, JE as per enquiry of State vigilance Organization were liable for causing loss to the exchequer amounting to Rs. 46,500/-

Whereas, based on the imputations and accusations as proved against the delinquent officers named above by the Vigilance Organization Kashmir, they were charge sheeted by the Inquiry officer.

Whereas, Inquiry officer after examining the replies and materials on record has submitted the report to the Managing Director. As per report, the Inquiry officer has reported that the above named officers have not acted in a prudent manner and as such, they should in no way absolved from the charges. However, the amount of Rs. 42,450/- subsequently released by Principal has been retained by SICOP and is lying credit against Principal Govt. Degree College, Kupwara.

Whereas, as directed by the Administrative Department vide letter No: IND/SICOP/11/2012 dated 24.10.2016 , an amount of Rs. 11,730/- has been recovered from delinquent officers and deposited the same in the Govt. Treasury under appropriate head.

Whereas, the Administrative Department vide letter No. IND/SICOP/11/2012 dated 15.01.2018 has also recommends for issuance of warning to them.

Now, therefore, it is hereby ordered as under :-

1. An amount of Rs. 42,450/- retained by SICOP should be refunded to Principal Govt. Degree College, Kupwara.
2. Mr. Shahid Sharief Dar, Estate Manager is hereby warned to remain careful in future in performing his duties.
3. Since, Mr. Shabir Ahmad Rafee has retired from Govt. Service, no warning is required to be issued against him.
