6. **Original copy of affidavit on Rs.50/- stamp paper** duly attested by **Judicial Magistrate Ist Class/ self attested** to the effect that:-

a) The documents/certificates etc enclosed with the Technical bid are genuine and have not been tampered or fabricated.

b) The firm has not been blacklisted in the past by any Govt/Private Institution of the country and there is no case pending in Vigilance/Any other investigating agency.

c) If any thing is found adverse in respect of documentation or otherwise, legal action warranted under law shall be initiated against the tenderer(s) submitting the tender.
