The Competent Authority has approved the rates of Concertina Coil for the fiscal 2020-21 as under:

1	Punched Tape Concertina Coil wire spiral of 50 turns having core wire of high carbon Spring steel of high tensile strength and low carbon steel strip of 19 mm wide, 0.5mm thick having series of sharp barbs punched all along the length of both sides of strip at regular intervals. The punch tap and the core wire should be electro galvanized to provide protection against the outdoor exposure. The punch tap should be mechanically crimped over the core wire and then formed into a coil. At various parts of the periphery of the coil , the individual turns of the coil should be connected to each other by steel clips so that it can be opened up like an accordion . Two handles and one spike should be provided at each side of the spiral to facilitate ease of handling. The length of the obstacle formed by the one coil when opened should be 15 m with an effective height of 915 mm. Weight of one concertina coil should be 15.2 Kg +-5%. Each coil should be wound with bituminized Hessian cloth to provide protective packing.	85.50	90.84

The approval is subject to the following conditions:-

- The above Purchase Rate as per Column No 3 shall be SICOP Purchase Rate from SSI Units and is inclusive of applicable GST of the item but exclusive of SICOP Service & Testing Charges @ 6.25% and shall be Ex Works.
- The above Sale Rate as per Column no 4 shall be SICOP Selling rate to the Department but inclusive of 6.25% SICOP service & testing charges & also, GST @ 18 % on SICOP Service & Testing Charges @ 6.25% and shall be Ex Works.
 - 3. The rate shall remain firm for the F.Y. 2020-21 and however, only subject to change as per GST rules.
 - 4. The Marketing Wing shall identify the quantity and intimate the sale rate to the intending department and also, to verify the availability of funds of particular supply order with the intending department. Moreover, atleast 20% on account payment may be released from the intending department while receiving supply order from them.
 - 5. The Testing Centre shall ensure adherence of the prescribed quality parameters.
