The approval is subject to the following conditions:-

- The above Purchase Rate as per Column No 3 shall be SICOP Purchase Rate from SSI Units and is inclusive of GST @ 18% but exclusive of SICOP Service & Testing Charges @ 6.25% and shall be Ex-Works
- The above Sale Rate as per Column no 4 shall be SICOP Selling rate to the Department but inclusive of GST @ 18%, 6.25% SICOP service & testing charges & also, GST @ 18 % on SICOP Service & Testing Charges @ 6.25% and shall be Ex-Works

- The rates worked out as above shall be revised from time to time based on the CACMAI circular, rates of Aluminum Wire Rod & HTGS Wire with base date of August 2020.
- The rates shall be offered to the indenting department as an open offer for their acceptance.
- In case the department opts to conduct inspection/testing on its own, then only 5% SICOP service charges shall be charged.
- The rates of ACSR Conductor shall be reviewed as and when the PDD approves the rates for the same during the current financial year and PVC shall be loaded with SICOP service/testing charges accordingly.
- 7. The Marketing Wing shall identify the quantity and intimate the sale rate to the intending department and also, to verify the availability of funds of particular supply order with the intending department. Moreover, atleast 20% on account payment may be released from the intending department while receiving supply order from them.
- 8. The Testing Centre shall ensure adherence of the prescribed quality parameters.
