2. The above Sale Rate as per Column no 4 shall be SICOP Selling rate to the Department but inclusive of 5% SICOP service charges & also, GST @ 18 % on SICOP Service Charges @ 5% and shall be Ex Works.
3. The Marketing Wing shall identify the quantity and intimate the sale rate to the intending department and also, to verify the availability of funds of particular supply order with the intending department. Moreover, atleast 20% on account payment may be released from the intending department while receiving supply order from them.
4. The rate shall remain firm for the F.Y. 2020-21 and however, only subject to change as per GST rules.
5. Since the facility of Test Check of these items is not available with SICOP, the manufacturer must give 18 months warranty of the item to the intending department.
