





2. The tender documents can be downloaded from the above website from **10-02-2016 (1200 Hrs)** onwards.
3. The bids shall be deposited in electronic format on website www.jktenders.gov.in from **10-02-2016 (1200 Hrs) up to 18-02-2016 (1700 Hrs) only**.
4. The uploaded pre-qual in the first instance on the website will be opened on **19-02-2016 (1400 Hrs)** in the office of FA/CAO, J&K SICOP, Jammu in presence of bidders who wish to attend. In case of holiday on the date of opening of bid, bids will be opened on the next working day at the same time and venue. The financial bids of only those firms shall be opened who qualify in pre-qual. Intimation in respect of opening of financial bids shall be notified separately.
5. Cost of tender document (In shape of Demand Draft) and Earnest Money Deposit (In shape of CDR/FDR) in original, favoring **Managing Director, SICOP** superscripted as "Technical Bid" should reach in the office of FA/CAO SICOP in person or through speed post/Regd post/Courier before due date & time of submission of bid. The corporation shall not be responsible for any delay due to any reason.
6. **Original copy of affidavit on Rs.50/- stamp paper** duly attested by **Judicial Magistrate Ist Class** to the effect that:-
 - a) The documents/certificates etc enclosed with the Technical bid are genuine and have not been tampered or fabricated.
 - b) The firm has not been blacklisted in the past by any Govt/Private Institution of the country and there is no case pending in Vigilance/Any other investigating agency.
 - c) If any thing is found adverse in respect of documentation or otherwise, legal action warranted under law shall be initiated against the tenderer(s) submitting the tender.
7. All documents as required in SBD should be uploaded with the technical bid.
8. **Complete bidding process will be online (Price Bid not to be submitted in physical form).**
