The Verification parties shall ensure 100% weighment/ counting of all stocks including earthquake material, which is available in packets and loose at RMD, Zainakote for which Mr. G.H Lone General Manager (M) shall be associated by the Sh. Mushtaq Ahmad Karnai Divisional Manager SICOP Baramulla. Wherever the stocks are under sale, sales be allowed & ground balance as on 31st March, 2018 be worked out.

In addition, the verification teams have also to submit separate annexed, signed by both Stock incharge & verification Officer, indicating unserviceable items available in their respective offices which are of no use & are required to be auctioned. Their book-value after allowing depreciation be also indicated.

The physical verification reports should be sent to the General Manager (J) for Jammu Division & General Manager Raw Material Kashmir for Kashmir Division & copy of the same to the Head Office within seven days from the date of completion of physical verification. The physical verification reports shall be consolidated with reasons of shortage, if any and their recommendations with regard to recovery & sent to the Head Office by 30th April, 2018 by the Divisional office Jammu & RMD Zainakote for Kashmir. Wherever the physical verification team find a glaring shortage of any kind or error, the same should be reported on the same day to Managing Director. The respective unit heads/ AFAs shall work out the closing stock evaluation & incorporate the same on the Physical Verification sheets/ reports.

The same evaluation shall be accounted for the year ending March, 2018. The stocks as verified by physical verification parties shall be taken as opening balance in the stock ledger for the year 2017-18. The physical verification parties shall strictly adhere to the above time schedule.
