TENDER NOTICE

For and on behalf of Jammu & Kashmir Small Scale Industries Development Corporation Ltd. (SICOP), sealed tenders are invited from reputed suppliers registered in India for the supply of the items given in Annexure – I, required for the maintenance & upkeep of Udyog Bhawan, Rail Head Complex, Jammu during the financial year 2016-17

1. The tenders accompanied with FDR/CDR for Rs. 50000/- (Rs. fifty thousand only) as Earnest Money Deposit (EMD) should reach the office of **Financial Advisor & CAO, J&K SICOP, Udyog Bhawan, Jammu by or before 22-03-2016 up to 1.00 P.M.** The tenders shall be opened on the same day at **4.00 P.M.** or any other convenient date in presence of tenderers who may wish to be present at the time of opening of the tenders.
2. The rates, inclusive of all taxes & duties, should be quoted in words & figures FOR Udyog Bhawan, Jammu without any overwriting/cutting.
3. No conditional tenders shall be accepted.
4. The material should have to be supplied in piece-meals within 02 days of placement of the order from time to time. Payment shall be released within 03 days of the receipt of each consignment from time to time.
5. Documents to be attached:
 - a) Original copy of affidavit on Rs. 50/- stamp paper duly attested by Magistrate 1st Class to the effect that:-
 - i. The documents/certificates etc enclosed are genuine & have not been tampered.
 - ii. The firm has not been blacklisted in the past by any Govt/private Institution of the country and there is no case pending in Vigilance/ Any other investigating agency.
 - iii. If anything is found adverse in respect of documentation or otherwise, legal action warranted under law shall be initiated against the tenderer (s) submitting the tender.
 - b) Valid Registration Certificate.
 - c) PAN No. / TIN No.
 - d) Experience, if any supply made to Government Departments
6. During the currency of the contract, if the successful supplier(s) sells material to other departments at price lower than the contract rate, "Price Fall Clause" shall be applicable on the whole contract.

7. In case the successful tenderer accepts repeat order from any Govt. Department/Autonomous Body directly on the strength of our rate contract, 2% service charges shall be recovered from the tenderer/purchasing department.
8. The SICOP reserves the right to accept or reject any tender or part without assigning any reasons thereof. Tenders without Earnest Money shall be rightly rejected.
9. The rates shall remain valid upto 31-03-2017.
